3. Discuss and consider allocating funds from the Apparatus account to rebuild Brush 12 with a new chassis, moving the brush skid from B3731, super single tire upfit, and emergency lighting.
4. Discuss and consider allocating funds from the Apparatus account to upgrade Squad 11 with a new chassis, and emergency lighting.
5. Discuss and consider allocating funds from the Apparatus account to upgrade Brush 15 (old Brush 14) with the heavy-duty chassis S5001 repurposed from Squad 11, modifications to brush skid to fit, larger water tank, and emergency lighting.

The individual executing the Citizen Comment Form understands that he/she is provided a limited amount of time, and that he/she may not be allowed to continue to address the Board of Emergency Services Commissioners if the comments are rude, disparaging or defamatory to any individual or entity, or the comments become disruptive to the good order of the meeting. If at a meeting of a governmental body, a member of the public or of the governmental body inquires about a subject for which notice has not been given as required by the Texas Open Meetings Act, the notice provisions of the Texas Open Meetings Act do not apply to a statement of specific factual information given in response to the inquiry; a recitation of existing policy in response to the inquiry; or, any deliberation of or decision about the subject of the inquiry shall be limited to a proposal to place the subject on the agenda for a subsequent meeting.
